THE COMPETITION ACT

(No. 12 of 2010)

EXCLUSION

THE PROPOSED ACQUISITION OF 1,822,375 SHARES OWNED  
BY JOS HANSEN AND SOEHNE GMBH IN JOS HANSEN AND  
SOEHNE (EAST AFRICA) LIMITED BY JOS ADRIAN GMBH

IN EXERCISE of the powers conferred by section 42(1) of the Competition Act, 2010, the Competition Authority of Kenya excludes the proposed acquisition of 1,822,375 shares owned by Jos Hansen and Soehne GMBH in Jos Hansen and Soehne (East Africa) Limited by Jos Adrian GMBH from the provisions of Part IV of the Act due to the following reasons—

- (a) the merger will not affect competition negatively;
- (b) although the combined turnover of the parties for the preceding year 2021 exceeded one billion shillings, the target turnover was KSh. 317,764,784.42;
- (c) the transaction meets the threshold for exclusion provided under the Competition (General) Rules, 2019.
